#### 1 Purpose

1.1 This policy sets out the process to obtain legal advice by members of the NSW Rural Fire Service (NSW RFS) required in the course of their NSW RFS duties.

## 2 Policy

- 2.1 All requests for legal advice, with the exception of clauses 2.2 and 2.3 below, must be sent via the normal reporting line, to the Director, Executive Services for review, and approval by the Executive Director, Finance and Executive Services.
- 2.2 Legal advice for Membership issues and Work, Health and Safety (WHS) incidents and investigations requires approval by the Executive Director, Membership and Strategic Services.
- 2.3 Urgent legal advice can be approved by an Executive Director.
- 2.4 To ensure central coordination of the legal function, notification is to be provided to the Executive Director, Finance and Executive Services of any legal advice requested under clauses 2.2 and 2.3. A copy of the advice received and the cost agreement is to be forwarded to the Legal and Government Information section as soon as practicable.
- 2.5 Requests for legal advice should be submitted using the Request for Legal Advice form.
- 2.6 For all other inquiries related to obtaining legal advice, please contact the Director, Executive Services.
