Supporting Arrangements:

In light of forecast conditions, Liaison Officers from the following Emergency Services Organisations and Functional Areas will be required from 0830 Hours on 12/02/2017:

All Emergency Services and Functional Areas

All other Emergency Service Organisations and Functional Areas should be on a heightened level of readiness to provide a Liaison Officer at short notice.

Consideration should be given to possible supporting requirements in the event of actual bush fire activity, including the provision of Liaison Officers at local Fire Control Centres and/or Emergency Operations Centres.

Vulnerable Facilities:

This advisory is not a direction from authorities to close facilities. Local Fire authorities and emergency services may issue specific advice regarding directed closures and/or evacuations in the event of fire.

Vulnerable Facility Managers within the affected areas should:

- 1. Stay well informed of current fire activity by monitoring local media and regularly checking for updates on NSW RFS website or information line;
- 2. Enact their facility Bush Fire Survival Plan; and
- 3. Contact their local fire authority to discuss implications and possible requirements.

Reducing the impact of bush fires is a shared responsibility between government, emergency service organisations and the community. Vulnerable Facility Managers play an integral role in taking the necessary steps to prepare their sites, staff and clients for the threat of bush fire in their local area.

Fires can threaten suddenly and without warning. At a Fire Danger Rating of Severe or above, fires are likely to be uncontrollable. When a Severe (or above) Fire Danger Rating is forecast, Vulnerable Facility Managers need to take warnings seriously and be prepared to act.
