# **COVID-19 FACT SHEET**

### **COVID-19 Response Levels**

#### **Principles**

- > The NSW RFS has established COVID-19 Response Levels.
- > State Operations will monitor public alerts regarding COVID-19 outbreaks and may assign a COVID-19 Response Level, based on health advice.
- The Response Level may apply to a NSW RFS site or location, or all NSW RFS locations in a District or LGA, depending on an assessment of health advice.
- > The Response Levels outline actions for staff and volunteers in the area or location identified.

#### Actions and Advice

There are three Response Levels, with the following principles:

- > The Response Level may apply to a NSW RFS site or location, or all NSW RFS locations in a District or LGA, depending on an assessment of health advice.

Actions for Districts / Areas / Head Office or Other Work Locations
