## **LIGHTING A FIRE – QUICK FACTS**

A quick guide to your responsibilities when lighting a fire or undertaking activities that may result in a fire

There are significant penalties if you light an illegal fire, or if your fire escapes and causes damage to property or the environment. It is therefore essential that you are aware of the legal and safety requirements before you conduct a burn or use equipment that is likely to ignite a fire.

When lighting any fire you should ensure that you are wearing appropriate clothing, have a water supply available on site and that

you have a cleared area around the perimeter of the fire. You must also use all practical means to prevent or minimise air pollution.

The following table provides a general guide to what you need to consider before lighting a fire.

The Clean Air Regulations prohibit the burning of certain items (including toxic items), along with general obligations to prevent or minimise air pollution. Contact the EPA for more information.

As a minimum you must have:  - 16L knapsack spray pump filled with water; or  - 9L liquid fire extinguisher; or  - 0.9kg dry powder fire extinguisher.	No  General purpose welding, grinding, soldering or gas cutting works cannot be carried out in the open on Total Fire Ban days.  There is a TOBAN Exemption process, notably for Welding

You must also notify any adjoining neighbours at least 24 hours in advance. You may need an environmental approval for the burn. For guidance, please refer to the RFS publication 'Before You Light That Fire' (see link below). Open burning may be prohibited in your local government area or you may need an approval for open burning (air pollution). The EPA is responsible for approving the smoke generated from burning of living vegetation, but your local Council can advise you on whether an approval is required in your area.
